

**THE WIZARDS RETURN: ALEX VS. ALEX SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN, NOR WILL A PURCHASE IMPROVE ONE'S CHANCES OF WINNING. MANY WILL ENTER. ONE WILL WIN.**

- 1. SPONSOR:** ABC Cable Networks Group, dba Disney Channel, 3800 W. Alameda Avenue, Burbank, CA 91505.
- 2. ADMINISTRATOR:** Ventura Associates International LLC, 60 East 42nd Street, New York, NY 10165, an independent judging organization whose decisions are final and binding with respect to the Sweepstakes.
- 3. ENTRY:** This Sweepstakes may only be entered by the Internet, during the period commencing at 5:30 P.M.(PDT), April 6, 2013, and ending at 5:30 P.M.(PDT), April 14, 2013 ("Entry Period") by watching "The Wizards Return: Alex vs. Alex" ("Show") and obtaining a code word ("Code Word") as follows: **[1]** Tune into Disney Channel on April 6, 2013, and watch for the special Code Word on the Show. **[2]** Then visit DisneyChannel.com/Wizards ("Website") during the Entry Period to enter the Code Word and complete your entry into the Sweepstakes ("Entry"). If you miss the Show, you may visit DisneyChannel.com/Wizards to obtain the Code Word. See local listings for local times for the Show.

As a registered member ("Member") of DisneyChannel.com you may enter by logging onto DisneyChannel.com/Wizards ("Website"), logging in with your Member Name and Password and following the "How to Enter" instructions ("Entry"). If you are not a Member, you may become a Member for free by visiting the Website and registering by providing the requested information on the Registration Form through the link on the site: "Not registered?" Upon becoming a Member by registration, you may enter the Sweepstakes by following the above instructions. Parent of a child under the age of 13 will be sent an email notifying him/her of the child's registration and Entry into this Sweepstakes. No response by the Parent to the email is required for the child to enter; however, if the Parent does not want his/her child to enter, Parent may click on a link in the email and complete the steps required to cancel the child's Entry and delete the child's information. Normal Internet access and usage charges imposed by your on-line service will apply. It is your sole responsibility to notify the Administrator if you or your Parent change email address ("Address"). To do so, go to <http://register.go.com/go/memberservices/home>, log into your Website account with your Member Name and Password, click on "Modify" and follow the instructions on how to change the Address.

- 4. LIMITATIONS:** All Entries must be received by 5:30 P.M. PST, April 14, 2013. Entries are limited to one Entry per person per Address regardless of whether one person has more than one Address or more than one person use the same Address. In event of a dispute regarding the identity of the person submitting an Entry, the Entry will

be deemed to be submitted by the person in whose name the Address is registered. Entries by any method other than set forth above in Paragraph 3 are void. Any use of automated or programmed methods of effecting Entry is prohibited. Open only to persons who are, as of Entry, 6 to 16 years of age, legal residents of, and physically located within, the 50 United States or D.C. ("Territory") and not employees of Sponsor or Administrator, their respective parent, subsidiary or affiliated companies; or the advertising, promotional or fulfillment agencies of any of them (individually and collectively, "Entities"); nor members of their households or immediate families. Neither the Entities, nor any of their officers, directors, shareholders, employees, agents or representatives (individually and collectively, "Releasees") are responsible for Entries from persons residing, or physically located, outside the Territory; Entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, late, lost, misrouted, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Rules; or for lost, interrupted or unavailable network, server or other connections; miscommunications; failed phone, computer hardware or software or telephone transmissions; technical failures; unauthorized human intervention; traffic congestion; garbled or jumbled transmissions; undeliverable emails resulting from any form of active or passive email filtering; insufficient space in entrant's email account to receive email; or other errors of any kind, whether due to electronic, human, mechanical, printing, production or technical errors or other causes; even if caused by the negligence of any of the Releasees. Each of such potential Entries will be disqualified. Void where prohibited or restricted by law and subject to all applicable federal, state, local and municipal laws and regulations.

**5. PRIZE: ONE (1) GRAND PRIZE:** one (1) Wizards Prize Pack consisting of the following props from the Show: **[1]** one (1) wand (as featured in the Show); **[2]** one (1) charm bracelet (as featured in the Show); **[3]** one (1) set of spell spheres (as featured in the Show). Approximate retail value ("ARV"): \$100. Any depiction of prize is for illustrative purposes only. Prize is not redeemable for cash or transferable. No substitution allowed except, at Sponsor's sole discretion, a prize of equal or greater value may be substituted. Prize cannot be used in conjunction with any other promotion or offer and elements may not be separated. Prize will be awarded provided it is validly claimed by May 30, 2013 after which no alternate winner will be selected, nor unclaimed prize awarded.

**6. PROCEDURES:** Entries will only be accepted during the Entry Period. On or about April 23, 2013, in a random drawing under the supervision of the Administrator, one (1) potential Grand Prize Winner will be selected from all eligible Entries received. Odds of winning depend on the total number of eligible Entries received.

**7. WINNER:** On or about April 24, 2013, the potential winner will be contacted by email to secure mailing address ("Email Contact"). Once mailing address is available, potential winner will be sent paperwork by overnight delivery service. All legal responsibilities under the Rules of a minor (as defined by state of primary residence) will be assumed by a Parent; and if prize is won by a Minor, it will be awarded in the name of the Parent for the benefit of the Minor. At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate winner may result from any of

the following: [1] potential winner's failure to respond to Email Contact within 3 calendar days after emailing by Administrator; [2] the return of any notice or the prize as undeliverable; [3] potential winner's failure to provide Sponsor with satisfactory proof of age, identity and residency; [4] potential winner's failure to execute and return an Affidavit of Eligibility/Liability/Publicity Release within five (5) business days after its mailing; [5] potential winner's failure to claim the prize within four (4) days after it is sent; [6] potential winner's failure to validly claim the prize by May 30, 2013, and [7] any other non-compliance with Rules. In the event of any prize forfeiture, the Sponsor may, in its sole discretion, award or not award the forfeited prize to an alternate winner. All taxes are solely the responsibility of the winner, who may (if applicable) receive an IRS Form 1099 reflecting the value of his/her prize.

CONDITIONS:** By entering this Sweepstakes and/or accepting any prize you may win, you agree, represent and warrant that: [1] you have all rights, permissions and consents necessary to grant the rights to Sponsor as expressed herein; [2] you will abide by and be bound by the Rules and the Sponsor's decisions and Privacy Policy; [3] the Entry becomes solely the Sponsor's property and will not be acknowledged or returned; [4] you release and hold harmless the Releasees from any and all liability for claims, injuries, losses or damages of any kind, including without limitation, death and bodily injury, resulting, in whole or in part, directly or indirectly, from the awarding, delivery, acceptance, use, misuse, possession, loss or misdirection of the prize; participation in the Sweepstakes or any Sweepstakes-related activity or travel or from any interaction with, or downloading of, computer Sweepstakes information; [5] the prize is awarded "AS IS" and WITHOUT WARRANTY OF ANY KIND, express or implied, (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose); [6] winner's acceptance of the prize constitutes the grant to Sponsor and assigns of an unconditional right to use winner's name, address (city and state only), voice, likeness, photograph, biographical and prize information and/or statements about the promotion for any programming, publicity, advertising and promotional purposes without additional compensation, except where prohibited by law; [7] in the event viruses, bugs, unauthorized human intervention, Acts of God, acts or regulations of any governmental or supra-national authority, war, national emergency, accident, fire, riot, strikes, lock-outs, industrial disputes, acts of terrorism or other matters beyond the Sponsor's reasonable control, corrupt, prevent or impair the administration, security, fairness or proper play of the Sweepstakes, so that it cannot be conducted as originally planned, Sponsor has the right, in its sole discretion, to modify the Rules or to cancel, modify, terminate or suspend the Sweepstakes; and in such event, to select a winner by such method as Sponsor in its sole discretion shall consider equitable; [8] the Releasees are not responsible for typographical or other errors in the offer or administration of this Sweepstakes, including but not limited to: errors in the advertising, Rules and selection and announcement of the winner; [9] any portion of the prize not accepted or used by the winner will be forfeited; [10] the Releasees are not responsible for any inability of the winner to accept or use the prize (or any portion thereof)

for any reason; **[11]** the Sponsor has the right, at any time and at its sole discretion, to disqualify any individual it suspects to be doing any of the following: **(a)** tampering or attempting to tamper with the entry process or the operation of the Sweepstakes or the Website; **(b)** violating the Rules; **(c)** violating the terms of service, privacy policy or other terms, conditions of use and/or general rules or guidelines of any Sweepstakes property or service or **(d)** acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person; or for any other good cause as determined solely by the Sponsor; **[12]** Sponsor has the right to lock out an entrant whose eligibility is in question or who has been disqualified or is otherwise ineligible to enter the Sweepstakes; **[13]** since any attempt by any individual to damage the Website or undermine the legitimate operation of this Sweepstakes or the Website is a violation of these Rules as well as criminal and civil laws, and should Sponsor believe or become aware that such an attempt has been, is being, or will be made, it has the right to seek remedies and damages from any responsible individuals to the fullest extent permitted by law, including without limitation criminal prosecution; **[14]** all disputes, claims and causes of action at law or in equity (individually, "Claim") arising out of or relating to this Sweepstakes, the meaning or interpretation of the Rules or any prize awarded shall be resolved by applying the laws of California, without regard to conflict of laws provisions therein, and shall be solely and exclusively brought in the state or federal courts within that state; **[15]** all Claims shall be resolved individually, without resort to any form of class action; **[16]** all Claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event include attorneys' fees, and under no circumstances will any entrant be permitted to obtain awards for, and hereby waives all rights to claim, punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses and waives all rights to have damages multiplied or otherwise increased, and **[17]** Sponsor has the right to modify prize award procedures at its sole discretion.
