- **2. ADMINISTRATOR:** Ventura Associates International LLC, 60 East 42nd Street, New York, NY 10165 ("Administrator"), an independent judging organization whose decisions are final and binding with respect to this sweepstakes ("Sweepstakes").
- 3. ENTRY: During the period beginning at 12:00:00 P.M., August 12, 2014, and ending at 11:59:59 P.M., September 23, 2014 ("Entry Period"), as a registered member ("Member") of Disney.com, you, as the entrant ("Entrant") mav enter this Sweepstakes via the Internet by http://www.partners.disney.com/magical-moments-sweepstakes ("Website"), logging in with your Member Name and password, following the "How to Enter" instructions and clicking on the "submit" button. After the initial registration, users may enter once per day for a total of forty-three (43) entries (individually and collectively, "Entry" or "Entries").

If you are not a Member, you may become a Member for free by visiting the Website and registering by providing the requested information on the registration form through the link on the site: "Not registered?" If you are already registered on Disney.com, you may log on to the site with your user name and password and follow the instructions (as described above) to enter the Sweepstakes. Normal Internet access and usage charges imposed by your on-line service will apply. It is your sole responsibility to notify the Sponsor of a change in your email address ("Address"). To do so, go to http://register.go.com/memberservices/home, log into your Disney.com account with your Member name and password, click on "Modify" and follow the instructions on how to change the Address. For purposes of these Official Rules ("Rules"), all times and days are Pacific Standard Time. Sponsor's computer is the official time-keeping device for the Sweepstakes.

Members will be required to click where indicated to signify that they accept and agree to be bound by the Terms of Use ("TOU") currently located at www.DisneyTermsofUse.com, these Rules and the decisions of the Administrator and Sponsor; which are final and binding in all respects. In the event of any discrepancy or inconsistency between the terms of these Rules and the Privacy Policy (as defined in section 8 below) and/or TOU, the terms of these Rules shall govern.

printing, production or technical errors or other causes; even if caused by the negligence of any of the Releasees. Each of such potential Entries will be disqualified and any attempt by a person to use multiple email accounts to register more Entries than allowed by these Rules may result in disqualification at Administrator's sole discretion. Void where prohibited and subject to all applicable federal, state, local and municipal laws and regulations.

Total ARV of all Prizes: \$34,500. A total of eight (8) prizes will be awarded.

Limit one (1) Prize per person per address. All expenses not specifically mentioned herein are not included and are solely a Winner's responsibility, and for the grand prize Winner ("Grand Prize Winner"), including but not limited to: round trip transportation between the Grand Prize Winner's

Website or undermine the legitimate operation of this Sweepstakes or the
